Meeting called to order at 4:23 p.m. by Shirlynn Webb.

A. Opening Exercises

Shirlynn Webb, Board Member, asked the Board to review and approve the meeting minutes from the last governing board meeting. Helena Del Monte motioned approval of minutes. Dalila Ruiz seconded the motion to approve the May minutes. All were in favor. Motion passed.

B. Public Comments

There were no public comments.

C. Principal Reports –

Doral International Academy- Mrs. Gomez reported enrollment at 887. Open house in September was a success. The Dad's day celebration was a hit and the Dads also assisted with morning arrival. There was 100% participation for Hispanic Heritage. The students participated in Red Ribbon week and will be entered in the city of Doral holiday show in December.

Everglades Preparatory Academy – Ms. Leyva reported enrollment at 1003. She noted students were excited to enter the NASCAR challenge. The open house was a success. The Dad's day celebration received a great turnout. A retired Marlins player will be cooking at the school with the students this year. The school is hosting their first musical soon.

Palm Glades Preparatory Academy – Dr. Vesga reported enrollment at 745. Dr. Vesga is happy with the progress of the school so far this year. The school met goals in Science and High School Math. There are three interventionists starting in April. The Senior parent meeting had 85% turnout and they also noticed a decrease in tardiness. Open house was a success for both middle and high school. Dr. Vesga reported the school is implementing an aggressive no bullying program. The professional arts program is up and running.

Advantage Academy of Math and Science at Waterstone and Charter School at Waterstone – Ms. Roque reported enrollment at 1110. The school had a smooth opening and successful open house. The donuts with Dad had a great turnout. The students recently participated in spirit week and the book fair. Red ribbon week was celebrated with a door contest for the teachers. Trunk or Treat was another success. The school recently hosted parent academy night which explained to parents how to help their child with academics.

Summerville Advantage Academy – Jeanette Reyes presented the Principal report. Ms. Coats was attending the "Meet and Greet" at the school. Ms. Reyes reported enrollment at 549. The school has several activities planned and recently participated in a successful Trunk or Treat with Palm Glades Academy.

D. Election of Officers

ANNUAL MEETING – Ms. Webb called the annual corporation meeting to order and asked for the election of officers. Helena Del Monte nominated Shirlynn Webb for the position of President and Dalila Ruiz seconded the nomination. Ms. Webb nominated Bassema Iskandarani for the position of Vice President and Ms. Ruiz seconded. Ms. Webb nominated Dalila Ruiz for the position of Treasurer/Secretary and Ms. Del Monte seconded. The corporate officer positions were voted on as nominated and all positions were filled as nominated without dissent. Ms. Webb called the annual meeting to a close to continue with the regular scheduled governing board meeting.

E. Information Items

1. RESUME GOVERNING BOARD MEETING - Mr. Strader reminded the Board that financial reports go out monthly. Any questions regarding financials may be directed to Brian Fisher.
2. A copy of the FY18 audits were sent to the board.
3. Mr. Fisher explained there was a transition from a third party provider to completing financials in house by CSA. The reason is to have greater accountability and cohesiveness in reporting. Mr. Strader noted the plan has been in place for years. The budgets presented today reflect data close to Survey 2 time period October 8-12; Survey 3 will begin in February. New for this year is the budget revision, looking at analysis early in the year. Mr. Drag worked with Principals to set up Safety Officer at each school.
4. Title 1 – Everglades Preparatory Academy, Palm Glades Preparatory Academy, Summerville Advantage Academy, AAMS@CSW and Charter School at Waterstone Title 1 funding were included in the board packet.
5. Joaquin Infante, Technology Director has good ideas to support devices in all the schools. Charter School Associates is investing in technology infrastructure and servers will be placed in colocation centers that can withstand a category 5 hurricane. The technology will be more robust and meeting the growing needs of the schools.
6. Charter School Associates is transitioning out their current payroll and benefit services. They will move from ACH Services to Ultimate Services which will allow for better services for school employees.
7. The proposed changes to the Financial Internal Control Policies modernizes language for the policy.
8. The Charter School at Waterstone was the first school to open and submit application to become the School Food Authority (SFA). Every school that has opened has been labeled as a site under CSW SFA authority. Changes were made last year so the SFA was invoiced collectively. Invoicing collectively (Interagency Agreement) stipulates a relationship between each school site (school) and CSW.
9. The Bylaws for Advantage Academy of Miami, Inc. have been brought up to date on how the board practices.
10. The fee update for Palm Glades Preparatory Academy is to improve cash flow at Palm Glades, CSA waived some historical fees.
11. The merger resolution between AAM, Inc. and CSW consolidates the boards and reduces

- the number of annual filings.
12. The application update for Palm Glades Preparatory Academy/High School is required to ratify the updated budget amendment.
 13. Ms. Webb noted the next meeting will be in February 2019.
